ORDINANCE NO. 701

AN ORDINANCE CONCERNING COURT FINES WITHIN THE  
CORPORATE CITY LIMITS OF THE CITY OF COLWICH, KANSAS:

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLWICH,  
KANSAS:

Section 1. The Judge of the Municipal Court for the City of Colwich, Kansas has set the following fines for the following traffic infractions and violations. The Clerk of the Municipal County and designated assistants are hereby authorized to accept from alleged violators by mail or in person his or her voluntary appearance, a plea of guilty or not contest, and the amount of fine shown for the infraction or violation. Ordinance violations and traffic infractions not listed on this fine schedule require a court appearance.

Fines listed on this fine schedule shall be doubled if the violation occurs within any road construction zone.

Fines listed on this fine schedule relating to exceeding the maximum speed limit shall be doubled if the violation occurs in a posted school zone.

The following fines are effective for incidents occurring September 1, 2017 or later. The fine amounts DO NOT include court costs.
