ORDINANCE NO. 722

AN ORDINANCE ADOPTING THE INTERNATIONAL RESIDENTIAL CODE, 2018 EDITION, WITH CERTAIN CHANGES AS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS IN SEDGWICK COUNTY RESOLUTION 120-2018; AND AMENDING ARTICLE 2, SECTION 4 OF THE WICHITA/SEDGWICK COUNTY UNIFIED BUILDING AND TRADE CODE AND CHAPTER 4 ARTICLE 5, Sections 4-503, 4-504, AND 4-505 OF THE COLWICH CITY CODE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLWICH, KANSAS:

- Section 1. ADOPTION OF THE INTERNATIONAL RESIDENTIAL CODE. The International Residential Code, as published by the International Codes Council, Inc., 2019 Edition is hereby adopted and incorporated herein by reference, subject to Section 4 of the Wichita-Sedgwick County Unified Building and Trade Code to the International Residential Code shall apply to the aforementioned version of the International Residential Code. All provisions within Article 2, Section 4 of the Wichita-Sedgwick County Unified Building and Trade Code prior to the passage of the resolution and ordinance adopting the 2018 International Residential Code shall remain unchanged, unless otherwise indicated within such resolution and ordinance. This Code and all amendments shall hereafter be known as Chapter 4, Article 5, Section 4-503 of the Colwich Municipal Code.
- Section 2. AVAILABILITY OF COPIES. One (1) copy of said code along with the amendments set forth in Sedgwick County Resolution 120-2018, have been and are now filed in the office of the City Clerk and the said code is hereby adopted and incorporated as if fully set out herein at length as authorized in the manner provided by K.S.A. 12-3009, et seq. This Code and all amendments shall hereafter be known as Chapter 4, Article 5, Section 4-504 of the Colwich Municipal Code.
- Section 3. AMENDMENTS. One (1) copy of said code along with the amendments set forth in Sedgwick County Resolution 120-2018, have been and are now filed in the office of the City Clerk and the said code is hereby adopted and incorporated as if fully set out herein at length as authorized in the manner provided by K.S.A. 12-3009, et seq. This Code and all amendments shall hereafter be known as Chapter 4, Article 5, Section 4-505 of the Colwich Municipal Code.

Section 4. <u>Repeal of Conflicting Ordinances.</u>

The provisions of any Colwich Ordinance adopting any earlier version of the International Building Code, are hereby repealed.

Section 5. Effective Date

This ordinance shall take effect and be in force from and after its adoption and publication once in the official City newspaper.
